**Chris Benner** is a doctoral student in the Department of City and Regional Planning at UC Berkeley. His research interests include international economic development, social and political implications of information technology, labor in the global economy, and community development. His dissertation research focuses on the rise of flexible employment practices in Silicon Valley labor markets and the implications for labor relations and workers' livelihoods.

**Manuel Castells** is Professor of City and Regional Planning and affiliated Professor of Sociology at the University of California, Berkeley. He is also Chair of the Center on Western European Studies. He has published and taught extensively on issues related to urbanization, social movements, the informal economy, and the rise of information technology. His most recent work, *The Information Age*, published by Blackwell Press, is a three volume set analyzing the transformation of society in the information age.

He teaches courses on public economics, planning and governing, and the urban planning process. His research interests include community development, public finance, and urban economics.

She is also a research associate in the Pepper Institute on Aging and Public Policy.
